

BASIC PRE QUALIFICATION ELIGIBILITY CRITERIA OF BIDDERS

In order to technically qualify the bidder shall fulfill the following basic pre-qualification eligibility criteria as on 31.03.2022. The Bidder must fulfill all the below mention basic pre-qualification as on 31.03.2022.

1. Consortium and Subletting is not allowed at any stage. A Commitment letter in this regard must be submitted along with technical bid
2. The bidder should be a registered company under Indian Companies Act, 1956 or 2013 or a Partnership firm or a Proprietorship firm for at least 3 years old.
3. The bidder should be registered with GST authority. Registration details clearly mentioned the Scope of Work along with form 3C(B) for September 2020 must be submitted along with technical bid or a company audit report as applicable.
4. The bidder should have a valid PAN/TAN number and should regularly fill the IT return. IT Return for financial year 2019-20 (assessment year 2020-21) and 2020-21 (assessment year 2021-22) and 2021-22 (assessment year 2022-23), must be submitted along with technical bid.
5. The Bidder must have a minimum Annual Turnover of Rs. 10.00 Lakhs (Ten Lakhs).
6. The bidder should not have been blacklisted by any State / Central Government / Government Department/Ministry/State/District/PSU/Autonomous Bodies in India for corrupt, fraudulent or any other unethical business practices or for any other reason. A self-declaration certificate on the company letter head must be submitted along with technical bid.
7. All relevant and required documents in support of the above pre-qualification condition must be submitted for consideration and evaluation of the bids in the cover containing technical bid.
8. Bidders must adhere strictly to all requirements of this Bid and submit all relevant papers as proof of their eligibility with technical bid.

Note :- The bidder must have diposit bank draft of Rs. 10000/- (Ten Thousand Rupees Only) for caution money in favor of Director, Secondary Education Jharkhand, Ranchi with Bid Document.
